ADOPTION OF THE AGENDA

CITIZENS INPUT

Hugo Lopez voiced concern over the Fats, Oils, and Grease Policy which is on the agenda. He stated that he felt the Board should know exactly what they are voting on before making a decision. He urged the to have a meeting with the engineer and listen to restaurant owners in town in order to become more informed.

Jamie Pratt voiced his concern to Mayor Faulkenberry that he felt that citizens were not given ample time to be heard, and were rushed when voicing concerns.

COMMUNICATION FROM MAYOR AND ALDERMEN

Mayor Faulkenberry asked Alderman Piper to read a declaration in which he declared September 17-23 to be Constitution Week. He also stated that he was very pleased with Homecoming, and was looking forward to the Halloween holiday.

Alderman Joyce stated that she had been approached about the Town of Chapel Hill having a Chamber of Commerce. The Board agreed to look into some options of how and if that could happen.

<u>REPORTS</u>

Mayor Faulkenberry asked that each Board Member look over the Fire Department and Police Department reports in their packet. No one had any questions about these reports.

Cassie Edrington gave the 2022 end of year financial report, and copies of the report were passed out to the Board at the request of Alderman Morton.

Town Administrator Danny Bingham informed everyone about the upcoming Newly Elected Officials Academy. He also read a letter from Henry Horton State Park, thanking our first responders for helping in a recent search at the park.

Alderman Joyce asked about several topics. The new police vehicle is being detailed. The new fire rescue boat is now in service. The new pumper truck is still at the dealer getting outfitted. The town is looking into options on a sewer back-jetter, including leasing one. The issues with the property at 901 Depot Street are being resolved.

Alderman Joyce asked what the plan was to operate under a sewer license since our current licensee will no longer be representing the city as of 9/15. We may need to contract it out until an employee can obtain their license or hire someone already licensed.
