### **CITIZENS INPUT**

- 1. Jason Gregg 2132 Daughrity Road expressed concerns regarding traffic and flooding in the area of Depot Street by railroad.
- 2. Ben Hudson 109 NW Chester Avenue expressed concerns regarding the proposed subdivision "The Groves of Chapel Hill," flooding, infrastructure strain and the increase of population possibly overcrowding schools, and inquired about where the development is in the approval process.
- 3. Travis Ross 2116 Old Highway 99 expressed concerns about the scale of the proposed project "The Groves of Chapel Hill."
- 4. Michael Mahew 1320 Old Highway 99 inquired if bonds or retainer would be in place for the proposed "The Groves of Chapel Hill" development for issues that arise after it is in place and expressed concerns that the increase of traffic causing more accidents.
- 5. Christine Dorrance 300 Depot Street expressed concerns regarding development causing more traffic and becoming more of a hazard, school zone traffic and fire response times due to the congested areas.
- 6. Koleen Little 58 Comstock Road stated that traffic signal lights need to be added at Highway 99, street light and mirrors are needed at the underpass at Depot Street and expressed concerns about mentioned roundabout not allowing farm and large equipment to come through.
- Marty Ness-White 1995 Overland Drive stated that the property she chose to purchase was due to the quiet area and with the # of homes proposed in the proposed development will impact the traffic drastically and inquired how could the town folk put a stop to the development.
- 8. Caitlyn Green 3615 Nashville Highway expressed concerns about EMS coverage and the school properties not being adequate to handle a large influx of new students.
