Water Availabilty

 Clarification was needed to determine the phase of development that a water availability study would be required. It is required as part of the submittal of a preliminary plat. Water availability would not be required of single lot development.

Maple Street Lots

• The residents from 105 Maple Street were in attendance. The residents and the Town Administrator verified that 107 Maple Street does not have a retaining wall. The residents had questions regarding the neighboring property and development thereof. It was also clarified that the drainage requirement noted on the Final plat as recorded by the Marshall County Tennessee Register in plat cabinet CABG, page 145A; is only for the lots created on that plat, not the neighboring lots that existed prior to that development.
